

**RED ROBIN'S SCORPION KIT SWEEPSTAKES**

**ELIGIBILITY:** Red Robin's Scorpion Kit Sweepstakes ("Sweepstakes") is open to Entrants who, as of the day of the Sweepstakes, are twenty-one (21) years of age or older and are legal residents of the fifty United States or the District of Columbia ("U.S."). Employees, family members of employees, and children residing with employees, officers or directors of Red Robin International, Inc.
